

## School Activity Consent for Gary Golf Cart

We have a very unique opportunity for our students at Walloon State School. We would like to offer the opportunity for students to ride as a passenger in Gary Golf Cart (Gazza). Students could ride in the golf cart for a multitude of reasons:



- As a reward (weekly prize draws)
- as a holder of a special golf cart pass
- to move an injured student
- school leaders assisting in putting equipment out on sports day (as an example) AND many other positive reasons

To facilitate this we had to complete an extensive risk assessment. Some of the control measures include:

- Only drivers with a current QLD drivers licence permitted
- When one adult – student in front, no more than 3 students on back (depends size of children)
- the golf cart is capped for speed, (no Fast and Furious for us!)
- students are briefed before participating in the ride for safety (keep all hands and feet in the cart at all times)
- parent permission is obtained

This is where you come in! We would like to obtain blanket permission for students, so they can access the golf cart at any time.
